



### Using the website to create an account:

After having CarLink installed, follow the steps below to create an account and begin using your system.

- 1. Go to www.CarLinkUSA.com and click Activate under CarLinkBT (ASCL5)
- 2. Enter your device's ESN, choose your service plan, fill out the account creation form and submit.
- 3. In the Welcome Email you will be prompted to login, create a vehicle and driver to complete the activation and registration process.

**NOTE:** Your Username and Password are case sensitive. When logging in, enter your Username and Password exactly as they were submitted during the registration.

### **Subscriptions and Remote Access**

There are 2 types of subscriptions available for this unit, BASIC (Remote Start ONLY) and PREMIUM (Remote Start with Location Services).

Use the icons on the Home/Keypad Screen to operate the CarLink features for your vehicle. For more information and updates please visit the CarLink website, www.CarLinkUSA.com

**NOTE:** Once a feature is activated, the length of time your vehicle takes to respond will be affected by cellular coverage or network congestion.

**NOTE:** Shaded icon buttons are features not available with your system. These are determined at the time of activation, please see your dealer for details.

### Download the smartphone app:

After having CarLink installed and account created - go to your device's App store to download the CarLinkBT mobile App (CarLinkBT Basic or CarLinkBT Premium for the respective service plan).
