## 12 MONTH LIMITED WARRANTY

Applies to AUDIOVOX Tablets

AUDIOVOX ELECTRONICS CORPORATION (the Company), warrants to the ORIGINAL PURCHASER of this product that should the product or any part thereof under normal use and conditions be proven defective on material or workmanship within 12 MONTHS FROM THE DATE OF PURCHASE, such defect(s) will be repaired or replaced with new or reconditioned product (at the Company's option) without charge for parts or repair labor. Accessories, if supplied will be warranted for only ninety (90) days.

To obtain repair or replacement within the terms of this Warranty, the product is to be delivered protectively packaged, with proof of Warranty coverage (e.g. dated receipt of sale), specifications of defect(s), transportation prepaid to the Company at the address shown below. All personal data should be backed up and removed before shipping. The Company will not be responsible for loss of any software or customer data.
